## LLPOA MOORING SITE AGREEMENT

**Mooring request deadline for lottery is March 15, 2010.**

### Please Read all the following Mooring Site Rules.

- Position your watercraft to the right of the LLPOA marker post, while on land facing the water.
- Three watercraft securing poles are required; two at the front of your watercraft (NOT on land) and one in the back. **Do not reposition or secure your watercraft to the LLPOA mooring marker post.**
- No docks or boat lifts are allowed in a mooring site. Transition platforms positioned on the land, Association property, will be allowed at the front of the watercraft.
- It is the responsibility of the mooring member to clean out the weeds at their assigned site.
- Any member causing damage to LLPOA property including damage caused by watercraft or poles will be charged the cost of repair to that property.
- Boats must be in the water by June 15<sup>th</sup>. If extenuating circumstances exist or if you should take your watercraft out of your site for any extended period, you must contact the office. Any unused mooring sites may be reassigned after June 16<sup>th</sup> on a first come first serve basis.
- When you remove your watercraft for the season, remove your poles. All personal property (i.e.: boats, poles, platforms, etc.) must be removed by November 15<sup>th</sup> in accordance with LLPOA Bylaws. Failure to comply will result in LLPOA removing the items. The member assigned to the site will be charged any associated costs, including storage fees for the items.

**Payment of \$100.00 is due when you receive notice of your assigned mooring site. Do not send the payment now.**

By signing this agreement I release LLPOA from any and all responsibility for any injuries that I or my guest may incur as a result of using this mooring site. I have read and understand all Mooring Rules and agree to abide by them. I understand that if I fail to comply with any of the rules I will forfeit my opportunity to moor a watercraft next season.
